13.2.2 access to or the operation of the Ligentix Service and/or any other programme or data, including the reliability of any programme or data (whether by re-arranging, altering or erasing the programme or data in whole or part or otherwise);

13.2.3 adversely affect the user experience of the Ligentix Service, including worms, trojan horses, malware, viruses and other similar things or
